The Tax Assessor Collector in Angelina County contacted this office immediately after the Primary Election to advise the Secretary of State of circumstances related to allegations that some votes were not tabulated correctly on election night. We are in communication with county officials and have been advised by the Tax Assessor Collector that she is working with the county attorney to request and ensure a recount occurs. Regarding the specifics of how the system was tested and how ballots were stored you should contact the county directly.

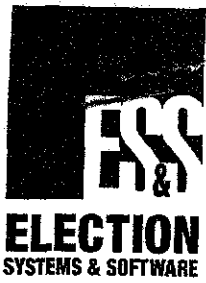

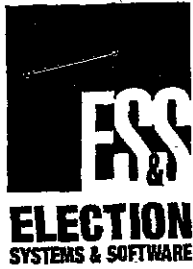
