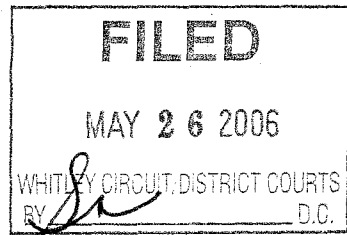

1. On May 16, 2006, numerous voters and candidates complained about the voting machines not working properly.
2. Elections results were not reported to the public in a timely manner, being more than two (2) hours after polls closed before the precincts were reported and some results were not reported until the morning of May 17, 2006.
3. Winners were announced before less than half the precincts were in.
4. Precinct results were reported as several precincts combined instead of individually.
5. Absentee ballots were reported inaccurately.
6. DRE voting machines are reported to be the most unreliable machines used in elections and the most simple machine to program. (See attached)

WHEREFORE, Plaintiffs prays that the election results be deemed incorrect and also for a re-election with unbiased parties overseeing the re-election in its integrity
